To the persons who are subjected to the Declaration of Assets and Liabilities in terms of Section 80(1) of the Anti-Corruption Act, No. 9 of 2023 and to the Heads of respective Institutions to whom the Declaration is to be submitted.

Declaration of Assets and Liabilities in terms of the Anti-Corruption Act, No. 9 of 2023

The Declaration of Assets and Liabilities Law, No. 1 of 1975 has been repealed by the Anti-Corruption Act, No. 9 of 2023 (Anti-Corruption Act), and Section 79 to Section 92 of the Anti-Corruption Act stipulates the legal provisions pertaining to the Declaration of Assets and Liabilities.

2. Accordingly, the Commission to Investigate Allegations of Bribery or Corruption (the Commission) as the Central Authority on Declaration of Assets and Liabilities is vested with the responsibility of installing a Centralized Electronic System (CES), facilitating the receipt and verification of the Declarations of Assets and Liabilities.
3. Currently, steps are being taken by the Commission to install the CES as required by the Anti-Corruption Act, and during the transitional period until the CES comes into effect or in instances in which the electronic system has collapsed due to technical failures, the Commission, in terms of Section 83(7), grants approval for the manual submission of Declarations.
4. The Declarant should submit the Declaration of Assets and Liabilities to the Heads of the relevant institutions, in accordance with the Format provided on the official website of the Commission to Investigate Allegations of Bribery or Corruption.
5. The said Declaration is to be submitted to the Head of the institution in the form of a signed printed document, completed using the Digital Format accessible on the official website of the Commission to investigate allegations of Bribery or Corruption.
6. The Head of the said institution is hereby directed to forward all such Declarations to the Commission to Investigate Allegations of Bribery or Corruption.

7. The persons subjected to the Declaration of Assets and Liabilities in terms of Section 80(1) of the Anti-Corruption Act are listed in *Column I* of **Annexure II**. The persons to whom the Declaration is to be submitted are listed in *Column II* of **Annexure II**.
8. The situations required by Section 82 of the Act to make the declaration of assets and liabilities are listed in **Annexure III**.
9. Further, **the Guideline for Completing the Declaration** of Assets and Liabilities is available on the official website of the Commission.
10. The facts you should pay attention to when submitting said Declarations to the Central Authority and the procedure to be followed are stipulated in the **Instruction Sheet (Annexure X)** attached to this circular.
11. You should take action to complete the Formats provided in the Instruction Sheet by giving the relevant information and email the soft copies to assets@ciaboc.gov.lk and submit their hard copies to the Commission along with the Declarations at the time you submit the Declarations to the Commission.
